



## Continuing Education Units

In order to maintain your CMRS certification, AMBA requires completion of 15 continuing education units (CEUs) annually. We have several methods of approved continued education.

CEUs must be earned in the calendar year following your initial CMRS Certification but before your anniversary date.

We will consider accepting CEUs that are not listed below. These types of CEUs might include magazine subscriptions, seminars, videos, online subscriptions, online courses, etc. Acceptance of non-approved CEUs will be considered on a case by case basis. Non pre-approved CEUs will be awarded at half the value of pre-approved CEUs. Effective Jan. 1, 2008, half of CEUs earned must come through AMBA training, courses, seminars, workshops, chapter meetings and etc.
